Article VII

Certificates and Dues

- 1. The Yin Yang Do Karate Association shall prepare certificates of rank which shall be used by all schools within the association and issued only to registered members.
- 2. Each student will be assessed a lifetime membership fee which will include one patch and one certificate. This fee will be determined by the Board of Directors.
- 3. Promotion certification will be issued at a fee determined by the Board of Directors.

Article VIII

Promotions

- 1. Student progress shall be judged on the following subjects:
- a. Character and attitude.
- b. Knowledge of Karate history.
- c. Perfection of fundamental stances, blocks, strikes and kicks.
- d. Mastery of the authentic Karate forms as prescribed by the Board of Directors.
- e. Knowledge and application of techniques.
- f. Length of time in Karate practice.
- g. Development of control, precision, power, speed and form.
- h. Teaching ability and assistance rendered to others.
- 2. Students should be recommended for promotion by the Sensei.
- 3. Individual Senseis will be allowed to rank a student within two grades of their rank. No student can attain a higher rank than his/her Sensei.

Article IX

Rank Designation

Requirements for rank Yellow belt (Schichikyu)

Basic stances, blocks, punches, strikes and kicks Kata: Omoto Ten, Karumpha, Geri Wasa 1 & 2, Taisu 1

Green Belt (Rokkyu)

Kata: Shorei Mege, Neko Buto Ich, Pinan Ich, National Dance Gaki Sei, Tai Chi Gedan Geri Wasa 3 & 4, Taisu 2
Open and closed hand tension wazas

Blue Belt (Gokyu) Kogeckis 1 through 7

Kata: Neko Buto 2 & 3, Saifi, Neko Buto 12, Stick Kata

Purple Belt (Yonkyu)

Kata: Neko Buto 4 & 5, Pinan 4 & 5, Anaku Geri Wasa 6 & 7, Taisu 3 & 4

Brown Belt (Sankyu, Nikyu & Ikkyu) Kata: Basai Dai, Naifunchin, Seenchin Gerei Wasa 8, 9 & 10, Taisu 5 & 10

Black Belt (Shodan)

Kata: No Hi, Tensho, Kan Ku Sho, Nandan Sho

Black Belt (Nidan)

Kata: Go Pei Sho, Sei Pai, Dan Enn Sho

Article X

Disciplinary Action

- 1. Any member of the organization may be expelled, suspended, subject to probation or otherwise disciplined by the Board of Directors for any of the following reasons:
- a. Malicious or disloyal utterances or acts against the association.
- b. Violation of any of the provisions of the constitution of this association.
- c. Conduct un-becoming a Karate-Ka, which does not fulfill the true spirit or purpose of this association.
- d. Committing a felony.

Upon receipt of a complaint against an individual the Board of Directors may appoint an investigating board, and charge them with the responsibility of conducting a hearing. The final decision in all cases will be with the Board of Directors, after consideration of the investigating board recommendation. No member may be disciplined without the benefit of a hearing. Only a senior Black Belt member or the Board of Directors can suspend any other member for any reason listed above, until a hearing for the accused can be arranged.

Article XI

Establishment of Schools

1. Any member who desires to establish a commercial school, open to the public, must first make their intention known to the Board of Directors requesting their recommendation.

Article XII

Amendments

1. This constitution may be amended by a majority of a vote in the presence of a quorum.
